Sport - 3mm High Density Polyethylene shell with an extrinsic rear foot posting and intrinsic forefoot posting. Includes 1/8" Poly-U Cellular Urethane from heel to toes with a Neolon top cover. Device is used for semi-flexible to semi-rigid control levels



Semi-Flex - 3mm High Density Polyethylene shell with an extrinsic rear foot posting and intrinsic forefoot posting. Includes 1/8" Poly-U Cellular Urethane from heel to toes with a Vinyl top cover. Device is used for flexible to semiflexible control levels.



Cork - Cork shell with intrinsic rear foot and forefoot posting. Includes 1/8" Poly-U Cellular Urethane from heel to toes with a choice of top covers. Device is used for flexible control levels.



Rigid - 4mm High Density Polyethylene shell with an extrinsic rear foot posting and intrinsic forefoot posting. Includes 1/8" Poly-U Cellular Urethane from heel to toes with a Neolon top cover. Device is used for semi-rigid to rigid control levels. Shown with optional arch fill.



Dress – 2mm High Density Polyethylene shell with intrinsic rear foot and forefoot posting. Includes 1/8" Poly-U Cellular Urethane extension to sulcus with a Vinyl top cover. Device is used for flexible to semi-rigid control levels.



UCBL - 3mm High Density Polyethylene shell with an extrinsic rear foot posting and intrinsic forefoot posting. Includes an EVA top cover to met heads. Device is made rigid with high medial and lateral flanges.



Diabetic – White Plastazote® shell with intrinsic rear foot and forefoot posting. Includes 1/8" Poly-U Cellular Urethane from heel to toes a Plastazote® top cover. Device is used for ultraflexible control levels.



Diabetic with Filler - White Plastazote shell with intrinsic rear foot and forefoot posting. Includes 1/8" Poly-U Cellular Urethane from heel to toes a Plastazote® top cover. Device is used for ultra-flexible control levels and is made to accommodate missing toes due to amputations.

Top covers included with its respective orthosis can be substituted with your choice of available top covers. These top covers include: Vinyl, Neolon, Plastazote® and EVA.

Gait Plate - 3mm High Density Polyethylene shell with an extrinsic rear foot posting and intrinsic forefoot posting. Includes 1/8" Poly-U Cellular Urethane from heel to toes with a choice of Vinyl or Spenco for the top cover. Device is made to control in toeing and out toeing.



SMO (Supra-Malleolar Orthosis) - Our SMO is designed to maintain a vertical or neutral heel while also supporting the three arches of the foot. Includes 1/8" Polyethylene shell with Volara cushioning for maximum comfort. Device is prescribed for patients who have soft, flexible, flat feet.



Hinged AFO - Our Hinged AFO is designed to allow range of motion of the ankle joint through the use of an ankle hinge. Includes a choice of plastic shell materials (Polypropylene and Co-Polymer) with varying thicknesses. Also includes a Durafoam liner with choice of thickness for cushioning and comfort.
